The company offers customizations for transportation vehicles with a focus on interiors, double cabs, volume boxes, aluminum flatbeds, and other specialized solutions tailored to customer needs. The business is based in Västerås, Sweden, with approximately 25 employees, and annual revenue currently amounts to just over SEK 60 million.
